CONDITIONS OF GUARANTEE: Client is responsible to immediately have the related specialist insure that all drains, drain lines, gutters and downspouts are free and clear of debris whether old or new. Roofing occurs normally once every 10-15 years and this work is mandatory to avoid false "roof" leaks. Additionally, regular inspection & cleaning of same (depending on roof traffic and surrounding trees/traffic that could get debris onto roof) is client's responsibility. The "additional Terms and Conditions" on the reverse side of the Royal/Client contract are also part of the above conditions. Client must have us perform regular preventative maintenance for a nominal fee over the years of the warranty.

NOTE: In the event that Royal Roofing is called out for a leak service and the leak is unrelated to our workmanship or materials applied, there will be a minimum \$125 fee charged for the cost of our specialists time in making such investigation. This is due to the massive number of calls that actually are unrelated to the Roof System application. These un-related items that cause such "false roof leaks" are but not limited to skylights, conduits, A/C duct work, filter racks, drains, stucco/siding cracks, window leaks, waterproofing, etc. are the normal responsibility of any property owner as regular home or building maintenance.
